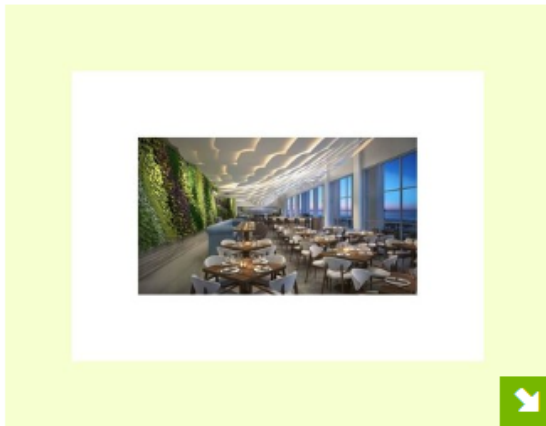


Conrad Fort Lauderdale Beach Residences to Launch with Douglas Elliman
